## New Policies

EFFECTIVE January 1, 2010

### **Cancellation Policy**

**Doggie Daycare** – requires a minimum of one (1) days notice to cancel an appointment. Owners that do not show for daycare on their scheduled day or that cancel with less than one (1) day's notice will be charged the scheduled daycare rate, per dog.

**Boarding**-cancellation requires 48 hours notice for general boarding stays and seven (7) days notice for boarding stays over holidays recognized by the US Postal Service. **\*\*Please NOTE!** For the time periods November 22nd – November 27th & December 22nd - January 2nd, a fourteen (14) day cancellation policy is in effect. If your reservation is NOT cancelled in accordance with our cancellation policy, you will be charged for the reservation in its entirety. Please understand our boarding space is in high demand & we strictly adhere to this policy. Thank you for your understanding!

### **Boarding Reservations Deposit**

Due to non-shows on boarding and our limited number of bedroom suites, we are requiring a deposit (\$50 per dog) prior to your stay to confirm your reservation.

### **Late Fees - Daycare**

There will be a \$15 per hour late fee for dogs picked up after scheduled closing time.

### **Payments**

**CASH or CHECK only.** All checks returned will be subject to a \$35.00 service charge. All payment is due at time of service.

### **Emergency Care**

In the case of accident or illness, Four Paws Playground, through its Certified Staff, will attempt to provide appropriate first aid and will notify the owner. Our staff is certified in Pet First Aid and CPR. If it is an emergency, we will take the dog to the vet. Costs of medical care beyond basic first aid are the financial responsibility of the ill or injured dog's owner.

### **Photography**

Four Paws Playground reserves the right to take photographs and/or videos during daycare or any event at their facility, and to use those photographs and/or videos for marketing purposes. As a participant in daycare or an event, you therefore are agreeing to let your dog's image be used in such photographs and/or videos. Parents who do not wish their dog's images to be used in this manner should notify Four Paws Playground in writing before the event or daycare.

### **Visiting any Dog Parks**

To prevent any unforeseen illness, all dogs that attend any type of dog park must wait two (2) weeks before attending daycare, boarding or training at Four Paws Playground.

**K - 9 Cough (Kennel)**

The first time your dog receives a Kennel Cough vaccination there is a two week incubation period. Booster Kennel Cough vaccinations require a 24 hour incubation period.

**On Leash**

All dogs must be on leash when entering and exiting the building. This is for the dog's safety.

**Office rules**

When dogs are in the office please refrain from having the dogs interact with other dogs or jumping on the parents for safety reasons. Allow other clients to enter or exit the office area before entering with your dog. Please use the "Enter" door to enter and "Exit" when leaving.

**Yearly Fecal Exam and Giardia Test**

For the health and safety of all of our clients, Four Paws Playground requires an annual fecal exam and Giardia screening. This is a simple stool exam conducted by your vet. New clients must be tested prior to entering daycare, boarding or training. Sorry for any inconvenience this may cause but we must ensure a clean healthy environment for ALL our dogs.

**Canine Influences Vaccination**

As of April 1, 2010, K-9 Influenza vaccine will be required. Please talk with your vet about the vaccination.

**Annual Requirements and Yearly Vaccination - 45 Day Grace Period**

All Four Paws Playground requirements must be up-to-date by no later than 45 days. This includes vaccinations, fecal test for worms and Giardia, and our paperwork (application, waiver, and policies) In the event, the requirements goes past the 45 day grace period, your dog will not be able to attend any of Four Paws Playground services.

**Year Documentation**

Each year, our required documents (application, polices, and waiver) will need be filled out.
